The new mortar manufacturing facility is located at Sika's local premises in Dubai Investment Park and complements the mortar production of the company's existing facilities in Bahrain and Saudi Arabia. Besides its local production plants, Sika UAE also has warehouse facilities in Dubai and Abu Dhabi for the storage of products manufactured by Sika companies worldwide in order to support the local markets on the Arabian Peninsula with a full range of solutions for their specific requirements.

On Réunion, Sika has been active for some 20 years through its subsidiary Sika France. The new production facility for concrete admixtures covers the needs of local construction companies and helps realize large-scale construction projects such as the new highway "Route de Littoral".
